

TO REVOKE THE BOSSI-FINI LAW: A NECESSITY

IT IS A LAW WHICH BLOCKS REGULAR ENTRANCE TO ITALY

For entering in Italy, the Bossi-Fini law has provided for an unrealistic criterion: families and companies should employ "from a distance" persons who still live in their countries, whom they do not know neither they have ever met. Everyone can easily see how crazy this criterion is.

Each year, on the occasion of "decreto flussi" foreign women and men, who are already in Italy to work, have "to pretend" that they are still in their countries" to be called": the "decreto - flussi" is just a disguised immigration amnesty. In this way, they have created clandestines and the regularisation of people who work and want to fit in Italy is prevented.

IT IS A LAW WHICH MAKES DIFFICULT TO REGULARLY STAY IN ITALY

If the factory you work in shuts down and you do not find a new job within six months, you are sent off. It is very easy to pass from the regular condition of your life to the irregular one, while the reverse is impossible. Even though you are regular and you have a steady job, you must wait for months before you get the renewal of your permit of stay. Immigrants, women and men, are working in agriculture, in construction, in services and as house servants. They are a crucial part of Italian society and economy, but they have less rights than Italian workers.

IT IS A LAW VIOLATING HUMAN RIGHTS

Today in our country democracy and rights State are both undermined in their fundamental principles. Inside the Centri di Permanenza Temporanea one is deprived of his own freedom without having committed any crime.

IT IS A LAW FORBIDING FULL CITIZENSHIP TO IMMIGRANTS

In our country there are almost 4 millions immigrants, most of them long since, with no right to vote. As if a whole Italian region were excluded from the suffrage

The Government had drafted the Ferrero-Amato law, an advanced mediation which would have made our country a little more civilized.

Many have opposed this chance. Many have preferred to invent a not-existing "security emergency", making of migration a problem of law and order

WE WANT

Lifelike ways of entering for looking for a job and on guarantee.

The modification of European politics about immigration that perpetuate the idea of Fortress Europe; the rescission of all existing agreements with countries which do not respect human rights.

A new law on citizenship based upon *ius soli*.

The ratification of a wholesome law on asylum.

The possibility for immigrants to apply for public competitions.

The right to vote for immigrants (steadily residents), at least at local elections.

Abolition of "contratto di soggiorno", extension of one's residence's permit, abolition of house requirements.

Cancellation of the agreement with Poste Italiane concerning the renewals of residence's permits and competence's transfers to local authorities.

Regularization of all migrants not included in the latest Decreto Flussi, of those who work illegally, of those who have already built their own social and relational network.

Inclusive politics for Rom and Sinti, beyond the camps.

The shut down of CPT and cancellation of all sorts of detention for administrative offences.
